BILL NUMBER: S2445

SPONSOR: SEWARD

TITLE OF BILL:

An act to amend chapter 443 of the laws of 2007 amending the tax law relating to authorizing the county of Cortland to impose an additional mortgage recording tax, in relation to extending the effectiveness of such provisions

PURPOSE:

The purpose of the bill is to extend provisions authorizing Cortland County to impose an additional mortgage recording tax for two years.

SUMMARY OF PROVISIONS:

Amends section 2 of chapter 443 of the laws of 2007 to authorizing Cortland County to enact a mortgage recording tax of twenty-five cents for each one hundred dollars of debt until December 1, 2011.

EXISTING LAW:

The current authorization expires on December 1, 2009.

JUSTIFICATION:

The Cortland County Legislature has requested the introduction of this legislation by Resolution 33-09.

LEGISLATIVE HISTORY:

Chapter 443 of the laws of 2007

FISCAL IMPLICATIONS:

None to state.

EFFECTIVE DATE:

Immediately.

LAWS OF NEW YORK, 2009

CHAPTER 257

AN ACT to amend chapter 443 of the laws of 2007 amending the tax law relating to authorizing the county of Cortland to impose an additional mortgage recording tax, in relation to extending the effectiveness of such provisions

Became a law July 28, 2009, with the approval of the Governor. Passed on Home Rule request pursuant to Article IX, section 2(b) (2) of the Constitution by a majority vote, three-fifths being present.

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

Section 1. Section 2 of chapter 443 of the laws of 2007 amending the tax law relating to authorizing the county of Cortland to impose an additional mortgage recording tax is amended to read as follows:

§ 2. This act shall take effect on the sixtieth day after it shall have become a law and shall expire and be deemed repealed December 1, [~~2009~~] 2011.

§ 2. This act shall take effect immediately.
